Take advantage of this year's career development opportunities with financial assistance from the IFMA Foundation! A number of grants are available to facility professionals, students and educators to fund continuing education, conference attendance and on-site training. IFMA membership is not required for eligibility. Apply today for the grant that best suits your educational needs!



Local Seminar Grant (\$500)

Organizations dedicated to the built environment can offset the cost of hosting a facility management seminar with this grant. The IFMA Foundation will match the organization's investment up to \$500 (U.S.) to enable the program to provide on-site training to its members or employees. Grants are awarded based on financial need.

Continuing Education Grant (\$1,000)

Don't let thrifty employers hold you back from your continuing education goals! Through this grant program, facility professionals who do not receive corporate educational funding can be reimbursed up to \$1,000 (U.S.) for the completion of degree, certificate or designation programs as well as continuing education courses.

Research Paper Award (\$5,000)

Contribute your research to the facility management community, and receive up to \$5,000 (U.S.)! Students and facility management professionals are invited to submit research papers that focus on facility management and the built environment. Applications must be received by May 31, 2007.

FM Educator Subsidy (\$500)

Educators need to stay current on the latest developments in the evolving field of facility management. The Foundation created this subsidy program to reimburse educators who have attended a facility-focused conference, seminar or class, up to \$500 (U.S.) annually per person per institution.
